	<ul> <li>Supervising children preparing for lunch, washing hands, etc.</li> <li>Ensuring children line up quietly and walk around school sensibly.</li> <li>Checking that dinner numbers are correct.</li> <li>Taking children to and from the hall.</li> <li>Supervising the fetching and eating of meals and serving drinks.</li> <li>Supervising the eating of sandwiches.</li> <li>Ensuring that good standards of behaviour are maintained.</li> <li>Dealing with spillages.</li> <li>Some aspects of clearing up after meals.</li> <li>Supervising and playing with the children on the playground or, on wet days, in the classrooms.</li> <li>Administering simple basic first aid.</li> <li>Tending to sick children and clearing up after accidents.</li> <li>Bringing children back into school after lunchtime and supervising in the classroom until the teacher returns.</li> <li>Supervising the use of toilets.</li> <li>Reporting any concerns to other school staff eg class teacher, Head teacher</li> <li>Supporting the school's policies on Behaviour, Equal Opportunities, Safeguarding and any other relevant policies.</li> <li>To meet with the Assistant Headteacher every half term.</li> <li>This is not intended to be a complete and exhaustive list of all duties and responsible attached to the post.</li> </ul>
